

1 **STATE OF WEST VIRGINIA, COUNTY OF MARSHALL, CITY OF MOUNDSVILLE,**  
2 **FEBRUARY 3, 2009**

4 The Council of the City of Moundsville met in Regular Session in the Council Chambers on  
5 February 3, 2009 at 7:00 pm.

6

7 Meeting was called to order by Mayor David Wood.

8

9 City Clerk called the roll and the following councilpersons were in attendance: Haynes,  
10 Saunders, Wallace, Young and Mayor Wood. Absent: Cunningham & Simms (ill). Also present:  
11 City Manager Hendershot, Police Chief Kudlak, Fire Chief Clarke, Street Foreman Stocklask,  
12 Building Inspector Wise, CPA Kathryn Goddard, Attorney Thomas White and City Clerk Hewitt.  
13 Absent: Street Commissioner Richmond.

15 **MINUTES:**

16

17 **Regular Council Meeting of January 20, 2009.**

18

19 Councilperson Haynes made a motion to accept and approve the minutes of the regular council  
20 meeting of January 20, 2009, seconded by Councilperson Saunders. Motion carried  
21 unanimously.

22

23 **GENERAL PUBLIC HEARING:**

24

25 **Presentation by Auditor's Office Regarding Purchasing Card System from Municipalities.**

26

27 Manager Hendershot introduced Jack Berry and B.B. Smith from the WV Auditor's Office who  
28 spoke on the purchasing card system for municipalities. Mr. Berry reported that legislatures  
29 passed a law which would allow the local governments to participate in the purchasing card  
30 system. The purchasing card is the same as another form of payment instead of using checks.  
31 This allows for electronic record keeping and control over the money that is spent. This will be  
32 no cost to the city.

33

34 Council referred this matter to the Finance Committee.

35

36 \* Kim Brooks, 208 11<sup>th</sup> Street, opposed the zone change ordinance at 1008 Thompson Avenue.  
37 Mrs. Brooks also presented letters from Mr. Brooks and Mr. & Mrs. Delong of 1010 Thompson  
38 Avenue who are in opposition of the zone change.

39

40 Councilperson Wallace made a motion to receive and file the letters, seconded by Councilperson  
41 Haynes. Motion carried unanimously.

1 \* David White, 406 Clinton Avenue, asked council who was in charge of cleaning the sidewalk  
2 on Jefferson Ext? Manager Hendershot advised the city responsible, but when we have large  
3 amounts of snow, the plows cover the sidewalk. Mr. White asked when the contractors were  
4 going to continue tearing down Fostoria? Manager Hendershot advised when the weather is  
5 better. Mr. White also asked how many times can a request for zone change be brought before  
6 council? Attorney White advised as many times as they wish.

7  
8 \* Millard Adkins, 298 Eleventh Street, commented that he and his wife oppose the zone change  
9 stating that since Co-op installed a fence his property value has already dropped \$10,000 so he  
10 does not want another business located by his property.

11  
12 **OLD BUSINESS:**

13  
14 **Removal of Fourth Ward Councilperson.**

15  
16 Councilperson Saunders made a motion to remove Councilperson Cunningham from the Fourth  
17 Ward Council Seat, seconded by Councilperson Wallace for discussion.

18  
19 After some discussion as to whether this motion should take place at this meeting or the  
20 following meeting, Councilperson Saunders and Wallace rescinded their motion and second.

21  
22 **NEW BUSINESS:**

23  
24 **Discussion and Approval of a Zone Change Ordinance for 1008 Thompson Avenue from R-**  
25 **M to C-C-C-H. (First Reading)**

26  
27 Attorney White read the following ordinance by title only to be passed by council on first  
28 reading:

29  
30 **AN ORDINANCE OF THE CITY OF MOUNDSVILLE, WEST VIRGINIA, PROVIDING**  
31 **TO CHANGE A CERTAIN DESIGNATED AREA AT OR NEAR 1008 THOMPSON**  
32 **AVENUE IN THE CITY OF MOUNDSVILLE FROM A MULTI-FAMILY**  
33 **RESIDENTIAL ZONE TO A COMBINED CENTRAL BUSINESS & HIGHWAY**  
34 **COMMERCIAL ZONE (FIRST READING)**

35  
36 Councilperson Wallace made a motion to approve the zone change ordinance, seconded by  
37 Councilperson Young for discussion.

38  
39 Councilperson Wallace commented that nobody complained when the property in question was  
40 an eye-sore but since Mr. Cunningham purchased the property, tore down the old building and  
41 cleaned up the property the neighbors want to complain.

42

1 Councilperson Haynes made a motion to table this matter until a later date. Motion died for lack  
2 of a second.

3

4 Mayor Wood called for a voice vote. City Clerk announced the following tally. 4 yeas, 1 nay.  
5 Haynes voting nay. Motion carried.

6

7 **Appointment to the Moundsville Planning Commission.**

8

9 Manager Hendershot received a letter from William D. McConnell asking to be re-appointed to  
10 the Planning Commission. Manager Hendershot will make the appointment.

11

12 **Discussion and Approval of a Resolution for the Purchase of a 2008 Chevrolet Uplander**  
13 **Van for the City of Moundsville.**

14

15 Councilperson Wallace made a motion to approve the resolution for the purchase of a 2008  
16 Chevy Van, seconded by Councilperson Haynes. Manager Hendershot advised the resolution is  
17 a formality to close the loan.

18

19 Mayor Wood called for a voice vote. City Clerk announced the following tally. 5 yeas. Motion  
20 carried unanimously.

21

22 **Discussion and Approval of an Ordinance Pertaining to the Codified Ordinances of the**  
23 **City of Moundsville ( First Reading)**

24

25 Attorney White read the following ordinance by title only to be passed by council on first  
26 reading:

27

28 **AN ORDINANCE OF THE COUNCIL OF THE CITY OF MOUNDSVILLE TO**  
29 **APPROVE AND ADOPT CURRENT REPLACEMENT PAGES TO THE CODIFIED**  
30 **ORDINANCES. (FIRST READING)**

31

32 Manager Hendershot explained his concerns of passing an ordinance that approves and adopts  
33 the codified replacement pages would put the city in a position to accept everything from the  
34 codifier. There have been instances where the wrong ordinance was printed and passed onto the  
35 city's replacement pages. Attorney White commented that he also had concerns and does not  
36 think it is necessary to pass another ordinance when the ordinances have already been passed by  
37 council.

38 Ordinance died.

39

40 **Other Items to be Discussed by Council.**

41

42 \* Councilperson Saunders asked what was decided about the right turn on red at 7<sup>th</sup> & Jefferson  
43 Avenue and 7<sup>th</sup> & Tomlinson Avenue.

1  
2 Street Foreman Stocklask commented the signs have to be a certain size to be a state route.  
3  
4 \* Councilperson Wallace reported seeing what he thought was state employees at the  
5 intersections of Rt. 2. Manager Hendershot reported the workers are from the gas company and  
6 assured Manager Hendershot they would contact him before they started working.

7  
8 \* Councilperson Saunders asked when the Christmas banners were going to be removed.  
9 Manager Hendershot advised there being problems with the bucket truck and short in staff.

10  
11 \* Councilperson Young reported the street starting to dip in front of Central School on 7<sup>th</sup> Street.  
12 Manager Hendershot advised 7<sup>th</sup> Street is State Route/US 250 but he will make a request to the  
13 state when they start their repairs.

14  
15 **MANAGER ITEMS:**

16  
17 **OVRTA - Ohio Valley Regional Transportation Authorities.**

18  
19 Council received a letter from OVRTA Board of Directors proposing the possibility of extending  
20 public transit service to Moundsville as well as Reynold's Memorial Hospital. If the proposal is  
21 implemented, the board is requesting a local transit levy be placed on the ballot at the next  
22 general election.

23  
24 Councilperson Saunders made a motion to send this matter to the Traffic Committee and invite  
25 Mr. Thomas Hvizdos, seconded by Councilperson Haynes. Motion carried unanimously.

26  
27 **Traffic Light Study.**

28  
29 Manager Hendershot sent a letter to WV Department of Transportation asking the state to remove  
30 the traffic light at 5<sup>th</sup> & Jefferson Avenue. Copies have been provided to council.

31  
32 **Police Civil Service Commission Appointments.**

33  
34 Letters were received by the Marshall County Chambers of Commerce to recommend the  
35 appointment of Rebecca Cox to the Police Civil Service Commission and Moundsville FOP to  
36 recommend the appointment of David Robinson also to the Police Civil Service Commission.

37  
38 Councilperson Wallace made a motion to receive and file the recommendation letters, seconded  
39 by Councilperson Saunders. Motion carried unanimously.

40  
41 **City of Moundsville Audit.**

42  
43 Manager Hendershot announced that the Auditor's Office has begun their yearly audit, fiscal year  
44 July 2007 through June 2008.

17 department heads decide on their needs.
