

1 **STATE OF WEST VIRGINIA, COUNTY OF MARSHALL, CITY OF**
2 **MOUNDSVILLE, JANUARY 26, 2021**

4 The Council of the City of Moundsville met in Special Session via Zoom on
5 January 26, 2021 at 5:00 p.m.

6
7 Meeting was called to order by Mayor David Wood.

8
9 Mayor D. Wood called the roll and the following councilpersons were in
10 attendance: Chamberlain, Hunt, Saunders, Wallace, S. Wood and Mayor D.
11 Wood. Absent: DeWitt. Also present: City Manager Healy, City Clerk Hewitt,
12 Finance Director Ankrom, Secretary Scarbin and Belomar Representative Natalie
13 Hamilton.

15 The Special Council Meeting was called for the following purpose:

17 1. Consider a Public Hearing for CDBG Application.
18 2. Discussion and Approval of a Resolution Certifying that 2021 City of
19 Moundsville Community Development Block Grant Program Funds will be
20 Expended for the Elimination of Spot Slum and Blight.
21 3. Discussion and Approval of a Resolution Authorizing the Filing of a
22 Community Development Block Grant Application to the State of West
23 Virginia.

25 **Consider a Pubic Hearing for CDBG Application.**

26 Natalie Hamilton of Belomar Regional Council was present to conduct the public
27 hearing and answer questions. Mayor D. Wood opened the public hearing for
28 comments and questions. Ms. Hamilton said the purpose of the public hearing is to
29 inform the residents of Moundsville that Belomar Regional Council is filing a
30 Community Development Block Grant application on behalf of the City of
31 Moundsville for demolition projects. If funded, the grant will provide funding for
32 eight houses to be demolished. The grant amount is for \$112,200.00 with the
33 city's contribution of \$34,000.00 making the total \$146,200.00.

35 Councilman Chamberlain moved to close the public hearing, seconded by
36 Councilwoman S. Wood. Motion carried unanimously.

38 **Discussion and Approval of a Resolution Certifying that 2021 City of**
39 **Moundsville Community Development Block Grant Program Funds will be**
40 **Expended for the Elimination of Spot Slum and Blight.**

1 Vice Mayor Hunt moved to approve the resolution, seconded by Councilman
2 Saunders. Motion carried unanimously.

4 **Discussion and Approval of a Resolution Authorizing the Filing of a**
5 **Community Development Block Grant Application to the State of West**
6 **Virginia.**

7 Councilwoman S. Wood moved to approve the resolution, seconded by Vice
8 Mayor Hunt. Motion carried unanimously.

11 Wood. Motion carried unanimously.
