A public hearing will be held on the following entitled Ordinance at a regular meeting of the Council of the City of Moundsville to be held on Tuesday, January 5, 2021, at 7:00 p.m., in the Council Chambers at the Moundsville City Hall, 800 6th Street, Moundsville, West Virginia, and at such hearing any person interested may appear before the Council and present protests, all objections and suggestions shall be heard by the Council and it shall then take such actions as it shall deem proper in the premises upon an Ordinance entitled:

ORDINANCE **AUTHORIZING** THE ACQUISITION, CONSTRUCTION AND **EQUIPPING** OF **CERTAIN** ADDITIONS, BETTERMENTS AND IMPROVEMENTS TO THE SEWERAGE SYSTEM OF THE CITY OF MOUNDSVILLE AND THE FINANCING OF THE COST, NOT OTHERWISE PROVIDED, THEREOF THROUGH THE ISSUANCE BY THE CITY OF MOUNDSVILLE OF SEWER REVENUE BONDS. SERIES 2021, IN AN AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00); DEFINING AND PRESCRIBING THE TERMS AND PROVISIONS OF THE **SERIES** 2021 BONDS: PROVIDING GENERALLY FOR THE **RIGHTS** AND REMEDIES OF AND SECURITIES FOR THE HOLDERS OF THE SERIES 2021 BONDS; AUTHORIZING EXECUTION AND DELIVERY OF ALL DOCUMENTS RELATING TO THE ISSUANCE OF SUCH BONDS; AND PROVIDING WHEN THIS ORDINANCE SHALL TAKE EFFECT.

The above-entitled Ordinance was enacted by the Council of the City of Moundsville upon petition of the Sanitary Board of the City of Moundsville on December 15, 2020.

The above quoted title of the Ordinance describes generally the contents thereof and the purposes of the Bond issue contemplated thereby. The City of Moundsville contemplates the issuance of the Bonds described in said Ordinance. The proceeds of the Bonds will be used to provide permanent financing the costs of acquisition of certain additions, betterments and improvements to the sewerage system for the City of Moundsville including, without limitation

the replacement of the manhole at 7th Street and Lockwood Avenue and related facilities. The Bonds are payable solely from revenues derived from the ownership and operation of the sewerage system of the City of Moundsville. No taxes may at any time be levied for the payment of the Bonds or the interest thereon.

A certified copy of the above-entitled Ordinance is on file at the office of the City Clerk of the City of Moundsville in the Moundsville City Building, 800 6th Street, Moundsville, West Virginia, for review by interested parties during regular office hours. <u>In light of the COVID-19 pandemic, you will need to make an appointment by calling 304-845-3394 if you would like to review the Ordinance.</u>

Following the said public hearing, the Council intends to enact said Ordinance on final reading and put said Ordinance into effect.
