The Council of the City of Moundsville met in regular session in the Council Chambers on April 16, 2013 at 7:00 PM.

- 7 Meeting was called to order by Mayor Eugene Saunders.
- 8 Invocation was given by Councilman K Mark Simms.

9

- 10 Acting City Clerk Ankrom called roll and the following Councilpersons were in
- attendance: DeWitt, David Haynes, Paul Haynes, Remke, Simms, Wood, and Saunders.
- 12 Also present were City Manager Hess, Police Chief Mitchell, Fire Chief Clarke, Public
- 13 Works Director Richmond, Building Inspector Richmond, CPA Goddard, Attorney White,
- 14 and Acting Clerk Ankrom. Absent was City Clerk Hewitt (vacation).

MINUTES:

- 17 Regular Council Meeting of April 2, 2013
- 18 Councilman Paul Haynes made a motion to accept the April 2, 2013 minutes as presented,
- 19 Councilwoman DeWitt seconded, and the motion carried unanimously.

GENERAL PUBLIC HEARING:

- * Bill Henthorne, Pastor of Solid Rock Baptist Church and new owner of Quality Bakery,
- 23 was informed by two different councilmen the Bakery would be "grandfathered" as a
- business, and that he would not be required to make certain upgrades in the building. The
- 25 Marshall County Health Department permitted him to operate the business; however, Mr.
- 26 Henthorne now feels threatened by certain City Officials with closure, if City building and
- 27 fire code regulations are not met. Some remodeling has been done with the funds and
- 28 resources that Mr. Henthorne has available. Business at the bakery has doubled since Mr.
- 29 Henthorne took over, and he has hired 10 employees.

- * Jane Klug of 2015 Jackson Street and President of the Marshall County Historical
- 32 Society provided copies of the proposed festivities celebrating West Virginia's 150th
- 33 birthday. Activities will be held on June 22, so as not to interfere with the City of
- 34 Wheeling's celebration; and venues include Riverfront Park, the Historical Society
- 35 Museum, and, possibly, downtown Moundsville. Former Governor Arch Moore will be
- 36 honored during the event. The Marshall County Commission has committed \$1,000.00
- 37 toward expenses; and members of local schools and 4-H groups will be involved. Ms
- 38 Klug encouraged more volunteers to help with planning, and a meeting will be held April
- 39 24 at 4:00 in the Council Chambers. Ms Klug also suggested a sign be posted near the
- 40 railroad tracks at the river, advising motorists that the track is "live" and to use caution
- when parking. Ms Klug also requested for Lockwood Avenue, from 13th to 14th Streets,
- 42 to be closed during the event.

* Vice Mayor Wood presented a motion to have his proposal, designating a Council liaison
to each of the Unifying Moundsville Action Teams, referred to the Policy Committee.
Councilman Remke seconded the motion, which carried unanimously.

- * Vice Mayor Wood noted the Home Rule legislation was approved, which will allow 16
- cities to apply for Home Rule. He encouraged Council to seriously consider this option, as a detailed plan will need to be formed. Vice Mayor Wood made a motion authorizing
- Mover Sounders to form a Committee to work on Councilla plan for Home Dule
- 16 Mayor Saunders to form a Committee to work on Council's plan for Home Rule.
- 17 Councilman Remke seconded the motion, which carried unanimously.

* Vice Mayor Wood commented the Mission and Values statements have been posted and look very nice!

- * Councilman Paul Haynes questioned Attorney White on Executive Session regulations,
- 23 as attorneys representing the WVU School of Law informed the Planning Commission
- 24 that Executive Sessions have to be included on meeting agendas. Attorney White
- disagrees, as he did research on this topic with the Ethics Commission. Vice Mayor Wood briefly described the topics discussed with the WVU attorneys and the Planning
- 27 Commission.

- 30 Discussion and Approval to Lay the Levy for the 2013-2014 General Fund Budget
- 31 Councilman David Haynes made the motion to approve laying of the levy for the 2013-
- 32 2014 General Fund Budget, which Councilwoman DeWitt seconded. CPA Goddard
- 33 explained the figures are received from the County.

Mayor Saunders called for a roll call vote, and Acting Clerk Ankrom announced the following tally: 7 yeas. Motion carried unanimously.

- 38 Discussion and Approval Endorsing Council's Support for the Heritage Trail
- 39 Walking Tour; Rail Trail Gateway & Extension; and the Rt 250 Corridor
- 40 Revitalization Plan
- 41 Vice Mayor Wood provided informational copies to the public in attendance and Council
- 42 members and asked for Council's permission to talk with citizens about the proposed

- 1 Heritage Trail, Rail Trail Gateway, and Route 250 Corridor. Vice Mayor Wood
- 2 emphasized that much work will need to be done; and West Virginia University students
- 3 will be working to identify historical sites along the proposed trails, that would be included
- 4 in a proposed smartphone application. Further discussion will be held at the Community
- 5 Awareness Seminar tomorrow evening, as well as during the remaining phases of the
- 6 Comprehensive Plan update.

- 8 Councilwoman DeWitt made a motion to lend Council's support for discussions with
- 9 citizens about the Heritage and Rail Trails and the Route 250 Corridor revitalization.
- 10 Councilman Remke seconded the motion. Mayor Saunders called for a roll call vote, and
- 11 Acting Clerk Ankrom announced the following tally: 7 yeas. Motion carried
- 12 unanimously.

Other items to be Discussed by Council

- * Vice Mayor Wood reviewed the meetings schedule for the Action Teams and provided
- 16 copies of the agenda for tomorrow evening's Community Awareness Seminar, along with
- brochures explaining the importance of participation in the meetings.

- * Councilwoman DeWitt mentioned that glass in the towers at the Former State Prison
- 20 continues to fall onto the sidewalk and street. The City Building Inspectors have made
- 21 contact regarding this issue.

- * Councilwoman DeWitt commented that potholes, caused by the company that worked
- on the 12th Street bridge, are still there. The Street Department can cold patch the holes
 - until more permanent repairs are made.

- * Vice Mayor Wood noted the WVU team will be back in Moundsville for a meeting on
- 28 May 3.

- * Vice Mayor Wood has been in contact with eight other cities about developing goals for
- 31 City administration. He encouraged other Council members to consider developing goals

COMMITTEE REPORTS:

Discussion of Recommendations by the Finance Committee

- **1.** The Finance Committee received and approved the March 2013 Financial Statements.
- **2.** The Finance Committee took no action, pending further information on funding for a proposed river front shelter.
- **3.** The Finance Committee tabled discussion on security cameras for Jefferson Avenue between 2nd and 5th Streets until additional cost figures are obtained.
- **4.** Vice Mayor Wood presented a motion to authorize expending \$336.00 for the Jefferson Avenue sidewalk template, which Councilman David Haynes seconded for discussion. It was clarified the template can be duplicated for use on any area of sidewalk, not just Jefferson Avenue; and whoever requests use of the template for sidewalk replacement will pay for the mortar used. Vice Mayor Wood amended his motion to authorize use of the template for anywhere in the City of Moundsville. Councilman Simms seconded the motion, which carried unanimously.
- 5. The Finance Committee recommends City employees assist with the hanging of banners, which the Uptown Moundsville Activities Committee will purchase, on Jefferson Avenue.
- **6.** The Finance Committee tabled discussion on the cost of cleaning wet lands along the Jefferson Avenue extension.
- 7. The Finance Committee recommends no change to the City logo.
- **8.** The Finance Committee denied a request from Simpson Church for a donation to the Hunger Walk.

Discussion of Recommendations by the Traffic Committee

- 1. The Traffic Committee recommends consideration of paving the following streets:
- A) Myrtle Avenue from 7th to 4th Streets, cost of which is estimated at \$73,414.00 with an additional \$25,000.00 to extend paving to the Fairgrounds.
- 42 B) Water Street from 14th to 16th Streets which is estimated at \$61,694.60.

- 1 C) 10th Street from Parriott Avenue to Garfield Street at a cost of \$38,111.70.
- 2 D) Center Street from Mulberry to Poplar Avenues at a cost of \$38,893.80.
- 3 E) Center Street from Ash to Cedar Avenues estimated at \$23,100.00.
- 4 The total cost of paying these five areas is \$260,214.10; and \$237,114.10 with the removal
- 5 of Center Street from Ash to Cedar Avenues. Vice Mayor Wood made the motion to pave
- 6 all five streets, including Myrtle Avenue to the fairgrounds, which Councilwoman DeWitt
- 7 seconded. CPA Goddard reminded Council only \$200,000.00 was budgeted for paving.
- 8 Vice Mayor Wood then amended his motion to pave the first four streets, but include
- 9 Center Street only if funds are available; Councilwoman DeWitt seconded the amended
- 10 motion. CPA Goddard again noted that these expenditures will exceed the budgeted
- amount. Vice Mayor Wood then rescinded his motion, and Councilwoman DeWitt
- 12 rescinded her second. After discussion, Councilman Simms made the motion to pave
- 13 Myrtle Avenue, including the area to the fairgrounds entrance, and to include Water Street,
- 14 10th Street, and both areas of Center Street, if the funds are available. Councilman David
- 15 Haynes seconded the motion, which carried unanimously.
 - 2. Councilman Simms presented a motion to approve the dedication signs at Grant Avenue and Center Street based on the written request from the VFW. Councilwoman DeWitt seconded the motion, which carried unanimously. Public Works Director Richmond will be donating the materials for the signs.

Discussion of Recommendations by the Policy Committee

- 1. The Policy Committee tabled discussion of revising Article 1107, dealing with Registration of Vacant Buildings, until more information is received.
- **2.** The Policy Committee recommended renewing the Sanford Center lease, which Attorney White has drafted and is awaiting approval from the Sanford board.
- 3. The Policy Committee recommends leaving the Municipal Fee Ordinance as it is.
- **4.** The Policy Committee took no action on the valuation of property at East End Playground.
- **5.** The Policy Committee recommends leaving as is Ordinance 505.13(b) pertaining to chicken coops.
- **6.** The Policy Committee took no action on the Home Rule application.
- 7. The Policy Committee took no action on applying for Town 180 as the deadline was not attainable.
- **8.** The Policy Committee took no action on meeting with consultants to discuss vacant buildings.
- **9.** The Policy Committee approved a resolution publicly supporting coal mine retirees, the draft of which is available.
