- 7 Meeting was called to order by Mayor David Wood.
- 8 Invocation was given by Councilperson K Mark Simms.

- 10 Acting City Clerk Ankrom called roll and the following councilpersons were in
- 11 attendance: DeWitt, David Haynes, Paul Haynes, Hendershot, Saunders, Simms, and
- 12 Mayor Wood. Also present: Acting City Manager Hewitt, Police Chief Mitchell, Fire
- 13 Chief Clarke, Public Works Director Richmond, CPA Goddard, and Attorney White.
- 14 Absent was City Manager Hess, due to illness.

- Mayor Wood asked those present to keep Manager Hess in their thoughts as she goes
- 17 through a difficult time.

19 MINUTES:

- 20 Regular Council Meeting of December 16, 2014
- 21 Councilman Paul Haynes made a motion to accept the minutes of the regular Council
- meeting of December 16, 2014, which was seconded by Vice Mayor Saunders; motion
- 23 carried unanimously.

GENERAL PUBLIC HEARING:

- 26 Mayor Wood took a moment to inform the public that Council members are not required
- 27 to respond to, nor make any immediate decisions based on, information provided during
- 28 the Public Hearing. They will respectfully listen and further research any concerns

Fire Chief Noel Clarke – Presentation to Firefighters

- 32 Chief Clarke informed Council the Fire Department's First Responder Program began in
- 33 1997, and his staff has become well trained. Although City of Moundsville firefighters
- have helped during many events, they have not received public recognition since 2012.
- 35 Chief Clarke had Mayor Wood and Vice Mayor Saunders present "Star of Life Awards"
- 36 to Assistant Chief Ron Walker and Firefighters Gary Brandon and Kevin Kimple. The
- 37 Awards note several dates since 2012 the responders assisted during critical situations.
- 38 Chief Clarke explained that paramedic training is very exhaustive and consumes one to
- 39 two years of a trainee's life; and he is very proud of the effort put forth by his firefighters!

- 41 Mayor Wood took a moment to welcome new Council member Allen Hendershot.
- 42 Councilman Hendershot thanked the citizens that voted for him and is "excited to serve!"

1 H Carl Boso Jr – Complaint of Councilperson

- 2 Councilman Simms offered an apology to Mr. Boso for a comment made at the previous
- 3 Council meeting; however, Mr. Boso was not accepting of the apology and feels
- 4 Councilman Simms is in the wrong for accusing Mr. Boso of lying.

Mr. Boso explained work he has completed on his Parriott Avenue property and questioned why other properties on this street, as well as other areas of the City, are not being addressed.

- 22 Consider for Adoption a Supplemental Resolution Which Would Approve Certain
- 23 Terms of the Not to Exceed \$400,000.00 City of Moundsville Building Commission
- 24 Lease Revenue Bonds, Series 2014, the Forms of Certain Documents to be Executed
- 25 and Delivered by the City of Moundsville in Connection with the Issuance of Such
- 26 Bonds and Matters Relating Thereto for the Purchase of the Kittle Hauling Property

27

- 28 Attorney White explained Tom Aman of Steptoe & Johnson PLLC presented a resolution
- 29 at this evening's Municipal Building Commission meeting, which was approved; and the
- 30 official closing will be tomorrow. Mayor Wood thanked Building Commission Chairman
- 31 Rickman, who was in the audience, as well as the other Building Commission members,
- 32 for their work and approval of the bond issuance for \$376,500.00. Mayor Wood explained
- 33 the term is for 12 years at a fixed interest rate of 2.64%, with the first payment to be made
- 34 February 7, 2015 and final payment in 2027.

35

- 36 Councilman David Haynes opined he thought this matter was tabled at the previous
- 37 Council meeting, which was confirmed to be correct. Councilman Simms made the
- 38 motion to bring the Supplemental Resolution off the table, which was seconded by Vice
- 39 Mayor Saunders and carried unanimously.

- Councilman Simms then made a motion to adopt the Supplemental Resolution to approve
- 42 the terms of the Lease Revenue Bonds. Motion was seconded by Vice Mayor Saunders.

Councilman Hendershot noted that, although he is not completely opposed to the process 1

itself, he is not fully informed and has some concerns, to which he is seeking answers. 2

Mayor Wood called for a roll call vote, and Acting Clerk Ankrom announced the 4

- following tally: six yeas, one nay, with Hendershot voting nay. Motion carried. It was 5
- noted the correct paperwork does identify the Bonds as "Series 2015" not "Series 2014." 6

- Ron Musser, attorney for Mr. Hunnell, provided a brief history of the area and rare use of 19 the roadways being abandoned. One of the alleys is a dirt road and nearly impassable. 20
- Mr. Hunnell owns all of the adjoining property and requests the abandonment to avoid 21
- setback issues with a future service facility to be constructed on the former Barr property. 22
