# STATE OF WEST VIRGINIA, COUNTY OF MARSHALL, CITY OF MOUNDSVILLE, FEBRUARY 5, 2013

The Council of the City of Moundsville met in regular session in the Council Chambers on February 5, 2013 at 7:00 p.m.

Meeting was called to order by Mayor Eugene Saunders.

Invocation by Councilperson Mark Simms.

City Clerk Hewitt called the roll and the following councilpersons were in attendance: DeWitt, P. Haynes, Remke, Simms, Wood and Mayor Saunders. Absent: D Haynes. Also present: City Manager Hess, Fire Chief Clarke, Police Chief Mitchell, Street Commissioner Richmond, Building Inspector Schneider, Attorney Thomas White, CPA Kathryn Goddard and City Clerk Hewitt.

## Regular Council Meeting of January 15, 2013.

Councilperson Remke moved to accept and approve the minutes of the regular council meeting of January 15, 2013, seconded by Councilperson P. Haynes. Motion carried unanimously.

#### **GENERAL PUBLIC HEARING:**

- \* Rich King, Uniquely Yours, asked where business owners are suppose to shovel snow from the walks if they are not permitted to shovel into the street? Council will discuss this issue at the Traffic Committee meeting.
- \* Dennis Kidd, 1215 Second Street, requested more patrol in the neighborhood of Second Street around Grant Avenue & Ash Avenue. He reported tools, air compressor and chain saw stolen from residence. Mr. Kidd also requested extra patrol for vehicle speeding in the same area.

#### **OLD BUSINESS:**

Discussion and Approval of an Ordinance to Abolish the Moundsville Building Commission. (Second Reading)

Attorney White read the following ordinance by title only to be passed by council on second and final reading:

AN ORDINANCE OF THE COUNCIL OF THE CITY OF MOUNDSVILLE, WEST VIRGINIA, ABOLISHING THE MUNICIPAL BUILDING COMMISSION. (SECOND READING)

Councilperson Simms moved to accept and approve the ordinance to abolish the Municipal Building Commission, seconded by Councilperson P. Haynes.

Mayor Saunders called for a voice vote. City Clerk announced the following tally. Wood, Mayor Saunders, DeWitt, P. Haynes, Remke and Simms voting yea. 6 yeas. Motion carried unanimously.

#### **NEW BUSINESS:**

Discussion of Recommendation by the Moundsville Planning Commission Denying the Request for a Zone Change at 1307 First Street from C-N to C-H.

Councilperson Wood moved to accept the recommendation by the Moundsville Planning Commission to deny the request for a zone change at 1307 First Street, seconded by Councilperson P. Haynes. Motion carried unanimously.

Discussion and Approval of a Resolution Authorizing the City Manager to Enter Into a Contractual Agreement with the Division of Justice Community Services to Receive and Administer Grant Funds from the Justice Assistance Grant for Prevention Resource Officer (PRO) at the Moundsville Middle School.

Councilperson Remke made a motion to approve the resolution to authorize the City Manager to enter into a contractual agreement for a Prevention Resource Officer (PRO) at Moundsville Middle School, seconded by Councilperson DeWitt. Motion carried unanimously.

Discussion and Approval of a Resolution Authorizing Application and Contract for the WV Governor's Community Participation Program Funds in the Amount of \$5,000 for Emergency Response Equipment for Police Cars Project.

Councilperson P. Haynes moved to approve the resolution to authorize application and contract for grant funding in the amount of \$5,000 for emergency response equipment for police cars, seconded by Councilperson DeWitt. Motion carried unanimously.

Discussion and Approval of a Resolution Authorizing Application and Contract for the WV Governor's Community Participation Program Funds in the Amount of \$\$2,000 for Ballfield Improvements at Valley Fork Park.

Councilperson Simms made a motion to authorize application and contract for grants funds in the amount of \$2,000 for Ballfield Improvements at Valley Fork Park, seconded by Councilperson P. Haynes. Motion carried unanimously.

Discussion and Approval of a Resolution Authorizing Application and Contract for the WV Governor's Community Participation Program Funds for Roof Repairs at the Moundsville VFW Post 437.

Councilperson Wood moved to authorize application and contract for grant funds in the amount of \$10,000 for roof repairs at the VFW Post 437, seconded by Councilperson P. Haynes. Motion carried unanimously.

- \* Councilperson Remke requested council review the handicapped ordinance and criteria at the Traffic Committee meeting.
- \* Councilperson Remke requested discussion at the Policy Committee meeting concerning Wholesalers who deliver in the city.
- \* Councilperson Remke asked if council has an idea on the cost of the Comprehensive Plan? Councilperson Wood noted since council is using Professor Stout, WVU Students, Community Design Team, local business owners, city and county officials, the city's cost would consist of sending the plan to a printer.
- \* Councilperson Remke suggested that CPA Kathryn Goddard provide to council more graphs on the finances and budget. Ms. Goddard will research her programs for capability.
- \* Wood Announced a Neighborhood Association Meeting has been scheduled for February 20, 2013, 6:00 p.m., at the FRN building at Second Street & Cedar Avenue. Second Ward representation will be present. Mayor Saunders said he would like to have invited Third Ward citizens also.
