- One candidate has been approved for hire for the Fire Department. He is currently going through the vetting process. Hopefully, we can announce him at the next meeting.
- One Lifeguard resigned, and one was hired one during the past month keeping staff at 6 active lifeguards. One Desk Attendant was hired during the month and one Lifeguard/Desk Attendant went on maternity leave resulting in 6 active.
- One Part-time dispatcher was hired, and applications are still being accepted for another part-time position. Applications are also continuing to be accepted for desk clerk and lifeguards at the pool.
- One of the Meter Attendants has submitted his resignation. The ad to fill that position has been running, and the deadline to submit an application is tomorrow.
- 15 1. Hopefully, everyone had a great Thanksgiving, and the employees appreciated the extra days off.
- 17 2. I received news last week that the long-awaited awards have been made on the
- 18 2020 Land & Water Grants. And Park View Playground was approved! This
- much-needed revitalization will give that park new playground equipment,
- 20 resurfaced courts, a reconfiguration of the Pickleball Courts, picnic tables, and
- trash cans. This project is approximately \$60,000, with Land & Water covering
- 50% of the costs. This will give a boost to an area that has not had sufficient
- 23 playground equipment for some time. Moundsville has a long history with the
- 24 Land & Water Program, receiving funds for the East End and Park View areas in
- 25 the early to mid-70's. Recently, we have received a grant and an amendment for
- Four Seasons Pool, and now Park View.
- 27 3. Continuing our relationship with Land & Water, I am working with Belomar on
- another application for the Riverfront Park Revitalization. Preliminary plans are
- 29 to include some additional fencing, a concrete pad for basketball and portable
- 30 pickleball court, new playground equipment, install fitness workout stations, new
- 31 picnic tables and trash cans, a dog park, and possible upgrades to the kitchen and
- restroom. This application is due December 31, with awards mid-2022.
- 4. The Christmas Parade held on Saturday, November 20 was a huge success. It
- was great to see the streets packed with people. Thank you to Mayor Wood, Vice-
- 35 Mayor Hunt, Councilwoman Sara Wood, and Finance Director Ankrom for
- participating. A huge thank you to the Street Department and Police Department
- 37 for their great contribution, and to Scott Reager and the Chamber of Commerce.

- 5. My wife and I shopped Jefferson Avenue on Small Business Saturday. Again,
- the streets were busy with shoppers, all enjoying the food trucks, free parking,
- 3 giveaways, and great service from the local merchants. Small Business Saturday
- 4 has evolved into a great day for small retailers. Once merchant told me it is their
- 5 biggest shopping day of the year. Thanks to the businesses that participated.
- 6. There is a bid opening scheduled Thursday for four surplus vehicles, most of
- which are located on the former Wilson property. A recent change in this process
- 8 is having these sales prior to the insurance renewal, which saves on the vehicle
- 9 portion, as the annual premium is based on a total number at renewal.
- 7. Renewal process has begun for our liability and property insurance with all
- department heads receiving a memo to check the equipment and automobile list
- currently insured. Over the last year, we have discovered that items that are
- insured, we may no longer have, or the value has dropped significantly, that they
- should not be listed. That renewal will be available at the January Finance Sub-
- 15 Committee Meeting.
- 8. DataMax collections for November totaled \$2,778.07, which nets the city
- \$1,389.04. That brings our running total to \$369,128.46, with a net to the city of
- 18 \$184,564.23.
- 9. There are numerous openings on Boards and Commission. Those available are
- 20 three spots on the Board of Zoning Appeals, two spots on Historic Landmarks
- 21 Commission, and one spot on the Building Commission. Anyone who is interested
- can supply a letter of interest to the City Manager.
- 23 10. Our Employee Christmas Luncheon will be on Friday, December 17, at noon.
- 24 Council is welcome to stop and join us here in Council Chambers. Boxed lunches
- and cookie trays will be provided.
- 26 11. Ms. Carole Wood, representing the Historic Landmarks Commission and
- Wreaths Across America, has invited City Council to a ceremony on Saturday,
- December 18th at 12:00 noon. This will be located at Riverview Cemetery on
- 29 Round Bottom Hill. US Congressman David McKinley will also be in attendance.
- 30 12. As the Christmas shopping season continues, please remember to patronize
- 31 our local businesses.
